# Performance with care for the environment

With its sophisticated and technologically advanced range of engines, Citroën is well placed to reconcile performance with low taxation levels and reduced environmental impact.

Today more than ever, this means that when choosing a Citroën vehicle you are guaranteed access to superb value for money motoring.

For example, the New Citroën C4 X PLUS, when specified with the Hybrid 136 e-DCS6 auto powertrain, produces 106 g/km of CO<sub>2</sub> while driving, and therefore qualifies for the F band of Vehicle Excise Duty.

### Company Car Benefit-In-Kind Taxation Charges

The Company Car Benefit-In-Kind Taxation charge is based upon the type of fuel used, and the level of CO<sub>2</sub> emissions, measured in grams per kilometre (g/km). The table below shows the percentage of the car's list price to be taxed (P11d value<sup>†</sup>).

For example, a New Citroën C4 X PLUS Hybrid 136 e-DCS6 auto has a CO<sub>2</sub> emissions figure of 106g/km and a P11d figure (as of April 2025) of £24,590.

The BIK value would therefore be 27% x £24,590 = £6,639.30.

Personal Lease is an alternative way to enjoy a new Citroën without the cost of ownership. Instead of owning the car, you rent it for a fixed period and then return it to your local retailer where you can exchange it for a brand new one.

You set your preferred contract terms and anticipated annual mileage. With leasing which can be arranged for a period up to 4 years, Personal Lease offers you an alternative method of funding your new Citroën. One initial bulk advance rental will be required. This is between 14%–16% of the 'On the Road Recommended Retail Price' plus any advance rental contribution from Citroën UK.
